Competitors may enter any level at a Fun Test, and may enter more than one level and/or multiple times at the same level (i.e., competitors may enter Novice multiple times with the same dog and/or may enter the same dog in Novice, Open, Senior, and Master).

Training is allowed in the ring. Handlers may carry and use toys in the ring. Treats will not be allowed in the ring.

EXHIBITOR INFORMATION

Qualifying Scores and Ribbons: Competitors do not earn qualifying scores toward any Barn Hunt title when participating in a Fun Test. Ribbons will not be awarded. Scores are not listed in the Barn Hunt Register.

Bitches in season may enter but must be kept separate from all other dogs and will run in panties at the end of their class. Entry fees for bitches that come into season will be refunded at the owner's request. The refund request must be accompanied by a letter or email from your veterinarian. *If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing. You must attend the general briefing each day to announce that your bitch is in season.*

Collars and Leashes: Electronic collars/devices and head halters are not allowed. Limited slip martingale collars, harnesses and single piece slip collars/leads are allowed. All dogs must be on leash at all times except when in the ring. At no time should dogs be tied out or otherwise left attached to something other than a human.

Collars and Leashes in the Ring: Dogs may not be brought to the ring in a disallowed collar or on a flexi-lead. Dogs may remain on a collar/harness and leash if no tunneling effort is to be attempted, and/or the handler may openly carry a collar/leash.

Crating: Crating will be out of your vehicle or tent. There is no room for dogs or crates to be in the barn when the trial is running.

Dog Height: Dogs are measured at the option of the judge or competitor.

Food Services: There are fast food restaurants within driving distance of the event location.

Possessing or Training with personal live quarry or litter tubes is not permitted.

Refunds: Entry fees will be refunded if requested prior to the closing date and for bitches in season (see above). Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. Entry fees will not be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, acts of God, public emergency, an act of a public enemy, fire, or any other cause beyond the control of the organizing committee.

GENERAL CONDITIONS

The safety of the dogs, handlers and rats is our primary concern.

By entering this trial, exhibitors acknowledge that they are familiar with the rules of this sport, and that their dogs are familiar with and able to perform all obstacles safely. Any dog that is sick, injured or lame will be excused from the trial grounds. Dogs that are loud and disruptive may be asked to locate away from the rings or crating area and/or staged away from the other dogs getting ready to compete.

It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the trial grounds.

Rats will be humanely handled and safely confined in aerated PVC tubes. Barn Hunt is not intended to harm or kill rats.

Dog exercise areas will be marked. Please pick up after your dog and dispose of waste in appropriate containers outside the building.

The rings are in a 3-sided building on dirt. Blinds will be covered and possibly tented.

Exhibitors are responsible for being ready to go from the staging area and waiting for their call to the gate. The judge need not wait for any dog. NADM Barn Hunt has no obligation or responsibility for providing service through a public-address system or steward for the purpose of calling or locating dogs.

Any dog that fouls the arena in any way (e.g. urinates, defecates, vomits) will be immediately excused. The handler is expected to clean up after the dog, both in the ring and out. A charge of \$8.00 per bale of straw will be charged for fowled bales.

There is **NO SMOKING** in any facility or on the trial grounds. Discard cigarette butts and E-cigarettes appropriately. Please do not litter!

DIRECTIONS

From Knoxville: From I-40 East, use the left 2 lanes to take exit 421 for 1-81 N toward Bristol. Take exit 57A for I-26 E/US-23 toward Asheville/Johnson City. Take exit 13 for TN-75 S/Bobby Hicks Hwy/Suncrest Dr toward Gray. Keep right at fork to continue toward TN-75 S/Bobby Hicks Hwy/Suncrest Dr. Turn right onto TN-75 S/Bobby Hicks Hwy/Suncrest Dr. Continue straight to stay on TN-75 S/Bobby Hicks Hwy/Suncrest Dr. Turn left onto Douglas Chapel Rd. In 200 feet, turn right onto CW Galloway Rd. Follow the signs.

From Asheville: Take I-240 W/US-70W. Take exit 4A for U.S. 19 N/U.S. 23 N/U.S. 70W/I-26 toward Weaverville/Woodfin. Take exit 13 for TN-75 S/Bobby Hicks Hwy/Suncrest Dr. Turn left onto TN-75 S/Bobby Hicks Hwy/Suncrest Dr (signs for Sulpher Springs). Continue straight to stay on TN-75 S/Bobby Hicks Hwy/Suncrest Dr. Turn left onto Douglas Chapel Rd. In 200 feet, turn right onto CW Galloway Rd. Follow the signs.
